

## SUMMARY OF THE PRIVACY POLICY

This summary of the privacy policy of UAB Gera dovana (hereinafter referred to as We or Data Controller) is intended to inform you of the essential principles of how the Data Controller handles your personal data obtained by visiting our websites, contributing to the project „LT♥UA“ or otherwise maintaining a business relationship with us.

### **Data processing purposes**

Personal data is processed to achieve the following objectives

- Provision of information relating to services / goods and company activities;
- Administration of orders for services and goods;
- Maintaining usual business relationships.

### **Legal basis of data processing**

Your personal data is processed with reference to one or several bases of legal processing: compliance with legal requirements; execution of a contract with you; our legitimate interests, except where such interests are overridden by your private interests.

### **What data do we process?**

The Data Controller handles the information about you that is necessary to provide you with our services / products. The information we collect directly from you will be obvious from the circumstances and context. For example: In order to provide the Services, we process the following information about you: name, email address, telephone number, payment method and payment-related details such as your bank account number.

### **To whom do we transfer your personal data?**

We can transfer your personal data to companies that provide services on our request (for data processors) and for the companies of “Gera dovana” group.

### **To which countries your personal data are transferred?**

Sometimes we may need to transfer your personal data to other countries. In such cases, we would do everything within our power to ensure the security of the transferred personal data

### **What do we do to protect your information?**

We have implemented intelligent and relevant physical and technical measures to protect your information. However, do not forget that while we are taking appropriate action to protect your information, no website, no online operation, no computer system or wireless connection is completely safe, therefore total security is not possible.

### **For how long we will keep your personal data?**

We will keep your personal data as much as it is necessary to achieve the stated objectives. Once our objective has been achieved, your personal data will be deleted, unless the law requires us to store that information or the data may be necessary for pre-trial investigation purposes, but in any case, the storage period will not exceed 10 years. After this period, the data will be deleted in such a way that they cannot be reproduced.

### **Your rights**

You have the right to access your data and to know how it is processed; request rectification or, taking into account the data processing purposes, to supplement incomplete personal data; in certain cases, you have the right to request the destruction of your data; in certain cases, you have the right to request the restriction of the processing of personal data; in certain cases, you have the right to transfer your data; the right to disagree with the processing of personal data when it is done

on the basis of your consent or our legitimate interest. You can also [file a complaint](#) with the Public Data Protection Inspectorate if you believe that your rights have been violated.
